





While some of the new assertions are not always initially mandatory, clients often take the opportunity to begin working towards compliance because they know it's the way forward and, in most cases, prompts the organisation to improve its security posture.

Our DSP Toolkit projects typically run on the following lines:

- Conduct a DSPT Gap Analysis meeting (as per the organisation type)
- Hold the GAP Analysis debrief meeting

- Undertake remediation tasks as per the project plan
- Track project and periodically report to the project sponsor
- On project completion, hold a project debrief to discuss findings and results and record the key lessons learned


